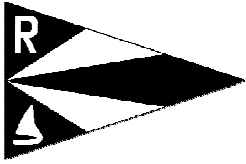

I also agree to indemnify and hold the Renton Sailing Club, its Board of Trustees, the City of Renton, and the Renton Parks Department harmless from any liability whatsoever, caused by or related in any way to use or possession of the Club's equipment and facilities by me, my family members or anyone else using a boat which is checked out to me.
