ARTICLES OF INCORPORATION
OF
RENTON SAILING CLUB, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, residents of the State of Washington, have associated and do hereby associate themselves together, for the purpose of forming a corporation under the statutes of said state.

I

The name of said corporation shall be RENTON SAILING CLUB, INCORPORATED, and its principle place of business shall be at 627 Fourth Avenue West, Renton, King County, Washington.

II

The corporation shall be non-stock and no dividends or pecuniary profits shall be declared or paid to the members thereof.

III

The general officers of said corporation shall be a President, Vice-President, Secretary and Treasurer. The affairs of the corporation shall be managed by a Board of Trustees of not less than three (3) nor more than nine (9) members.

IV

The officers of the corporation shall be elected by the trustees, who shall first be elected by the members of said corporation.

V

The primary purpose of this corporation shall be to promote and advance small boat sailing through:

1. Organizing and operating a small boat sailing school each summer dedicated primarily to junior sailing.
2. Encouraging the growth of organized, competitive small sailboat racing.

3. Providing boats and facilities to accomplish the foregoing purposes.

4. To assist and co-operate with all governmental agencies, federal, state or local in pursuance of their endeavors as they concern small boat sailing and other related activities.

5. To establish necessary relations with other organizations or agencies to help promote the aims and purposes of this organization.

VI

The private property of the individual members of this corporation shall not be liable for its corporate debts.

The corporation is to have perpetual existence.
